Washington Student Achievement Council

As a result of HB 2483, the HECB was dissolved and the WSAC will assume most of the responsibilities the HECB previously held. Our great HECB staff will remain and carry over to the new council to administer student financial assistant programs. Information previously on the HECB website is now www.wsac.wa.gov

According to the HECB "The Washington Student Achievement Council will be composed of nine members, five from the public (including a postsecondary student) and four from the following education sectors: the Office of the Superintendent of Public Instruction, the four-year public universities, the State Board for Community and Technical Colleges, and the Independent Colleges of Washington. New council members will be selected by the Governor."
